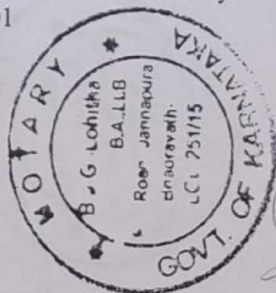
6. This Educational Society shall comply with all the government ordinances in force and to be issued as and when in connections with the Educational Societies, and shall strictly comply with the Acts under the Karnataka Integral Education (Karnataka Act 1 : 96) Act, 1983 and the rules framed there under and which will be framed now and then.
7. As per the Government Notification No. ED 175 P.M. C 95 dated 07-09-98 and dated 29-12-98, the registration of this Primary School will be permanently without aid school. An affidavit stating that the school will not avail any aid from the government should be declared by Notary in stamp paper of Rs.10/-.
8. The Rules prescribed under the Karnataka Private Educational Institution(Discipline and Control) Rules 1999, shall be strictly followed/abide by them.
9. That according to the Karnataka Educational Institution (Classification, Control and Prescription of Syllabus, etc.) the Text Books only prescribed by the department and government shall be taught and Examination procedures to be followed.
10. The number of students in each class shall not exceed 25.
11. The Teachers should be appointed as per the norms. As per the Rule 8 and Section 36 and 39 the First Recognition and Renewal of Recognition has to be sought from the Department after opening the School.
12. All the students have to undergo Medical Examination every year.
13. A fixed deposit shall be made in the Joint account of Deputy Director of the District and Secretary of the Administrative Board
14. That as per the Karnataka Integral Education Rules, the required furniture, library and other facilities within one year and the playground and school building within three years shall be provided.
15. The information with regard to opening of the school and admission of the students shall be submitted to this office within three months of the commencement of the academic year. In case of non-opening of the school and violation of any terms and conditions, the grant of order will be automatically stands cancelled.
16. Separate toilets should be provided to the boys and girls. Drinking water facility should be provided.
17. First Recognition has to be obtained within three months from the Deputy Director according to the Government order dated 30-09-2007 based on the checklist available in Subrule 3 otherwise the permission will automatically gets cancelled.
18. The dangerous zones existing in the school compound should be fenced and the compound shall be constructed for the safety of the children and necessary safety measures shall be taken for avoiding fire accidents. A display board stating that no Tobacco and Tobacco related products should be sold within 100 meters of the School zone.
19. In the event of any of the documents submitted in the proposal for registration found to be false documents, then this registration will be cancelled.
20. The rules prescribed under Government Notification No.ED 369 PGC 2014 dated 11-11-2014 of the Karnataka Educational Societies and Circular dated 14-11-2014 shall be strictly followed.
21. The rules prescribed under Government Notification No.ED 709 PGC 2017 dated 07-03-2018 of the Karnataka Educational Societies and Circular dated 26-03-2018 shall be strictly followed.

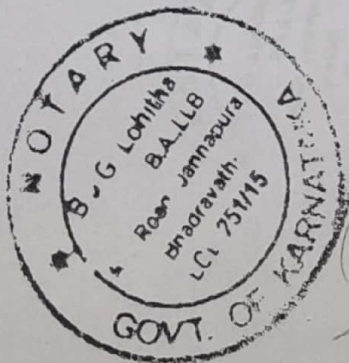

8. The students should not be denied an admission based on Date of Birth, Religion, Caste, Creed and place of birth.
9. The School should follow the below conditions :
 - i) The student who is admitted to the School should not stay away from Class and School.
 - ii) No Student should be tortured mentally and physically.
 - iii) Any student should not be forced to Pass the Board Exam until the Student completes Education.
 - iv) After completion of the Course the student should be issued certificate as per the Section 30.

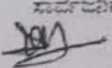
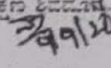
